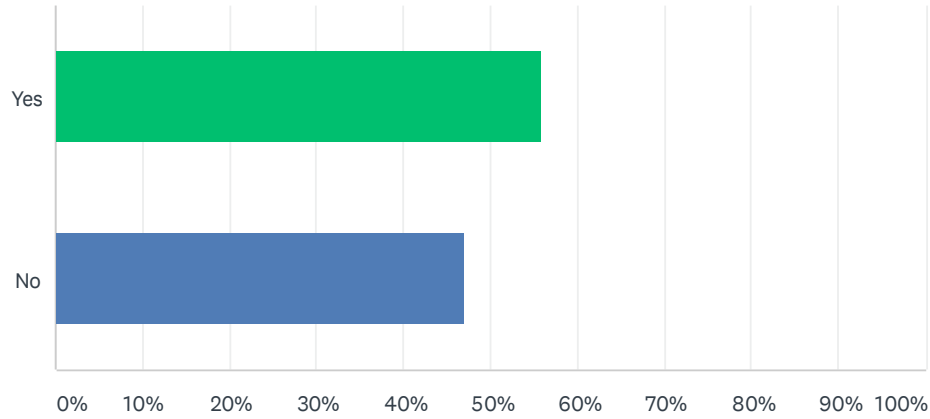


## Q1 Has your family been financially impacted through involuntary loss of job or unpaid leave?

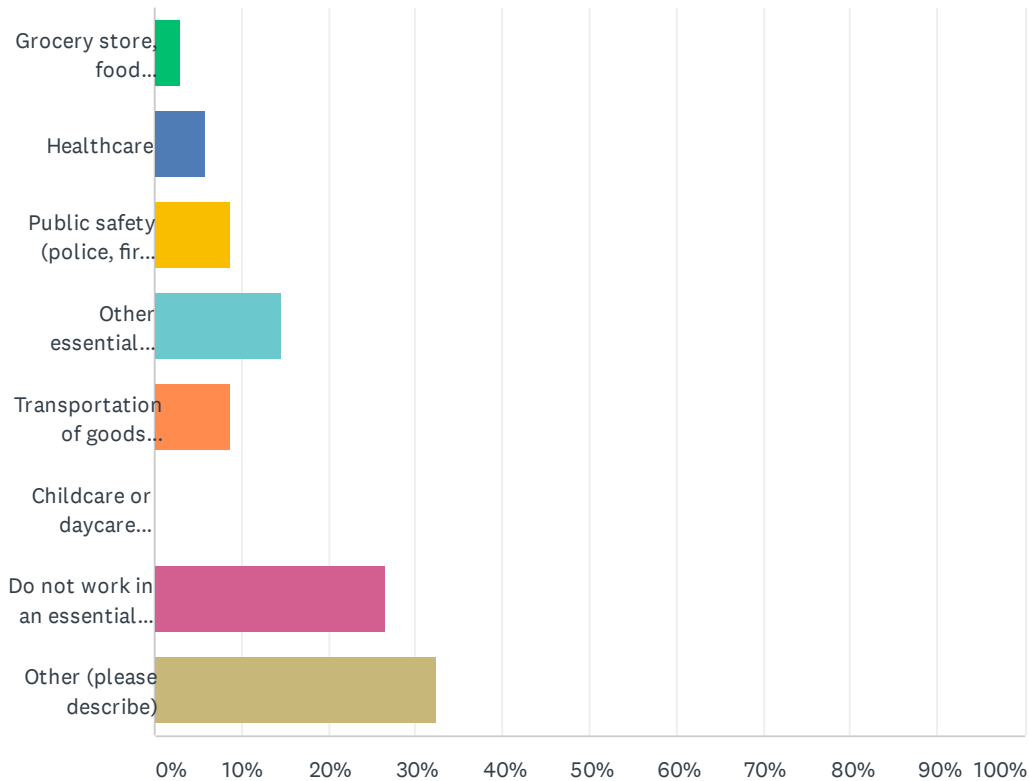

## Q2 Do you work in an essential industry?

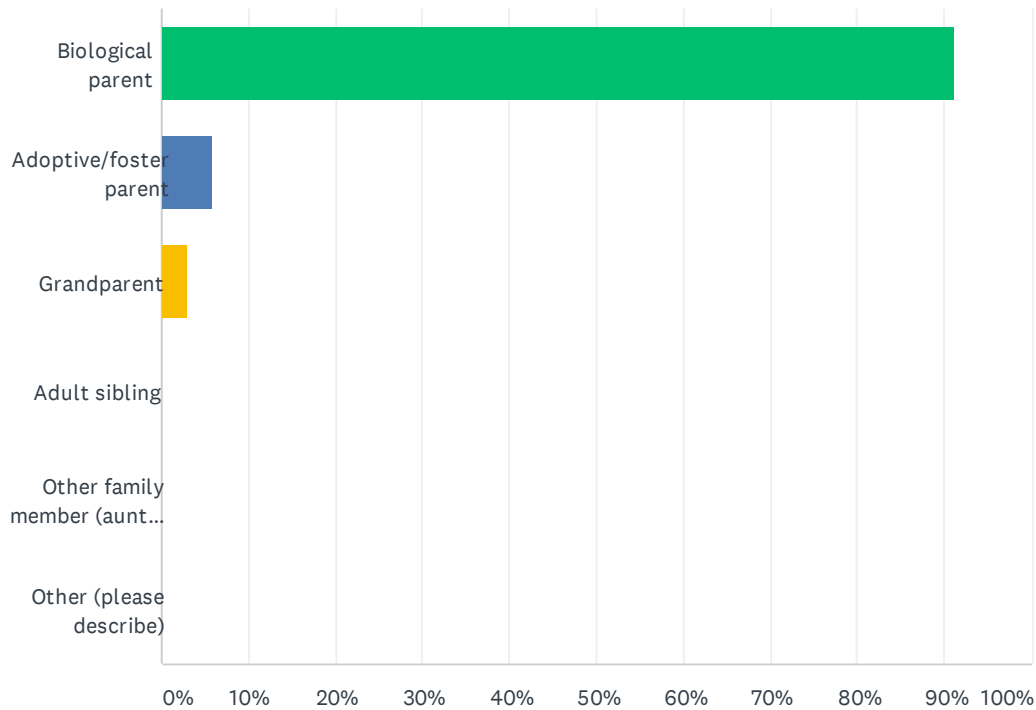

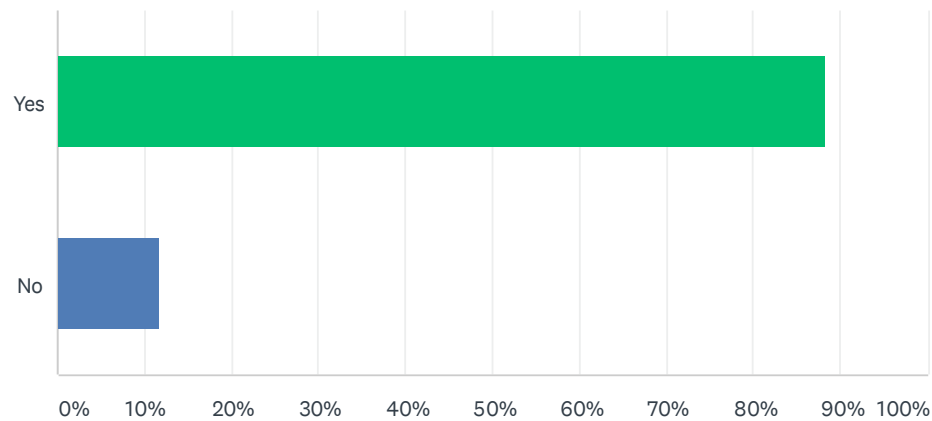

## Q4 Do you have access to the technology needed to accommodate remote learning for your children (high speed internet, computer availability, etc.)?

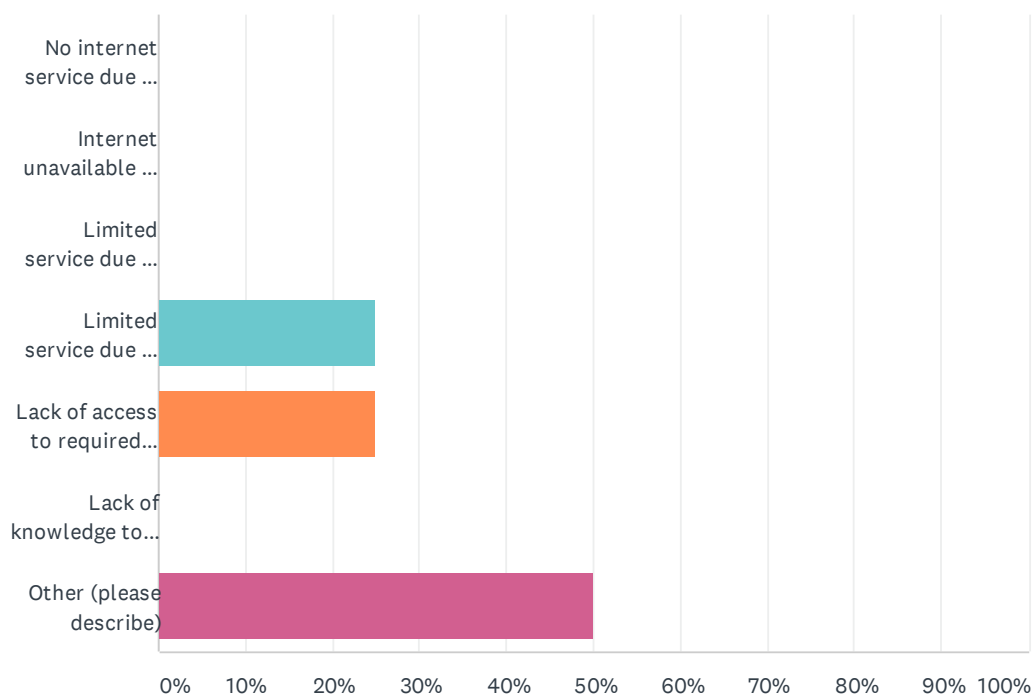

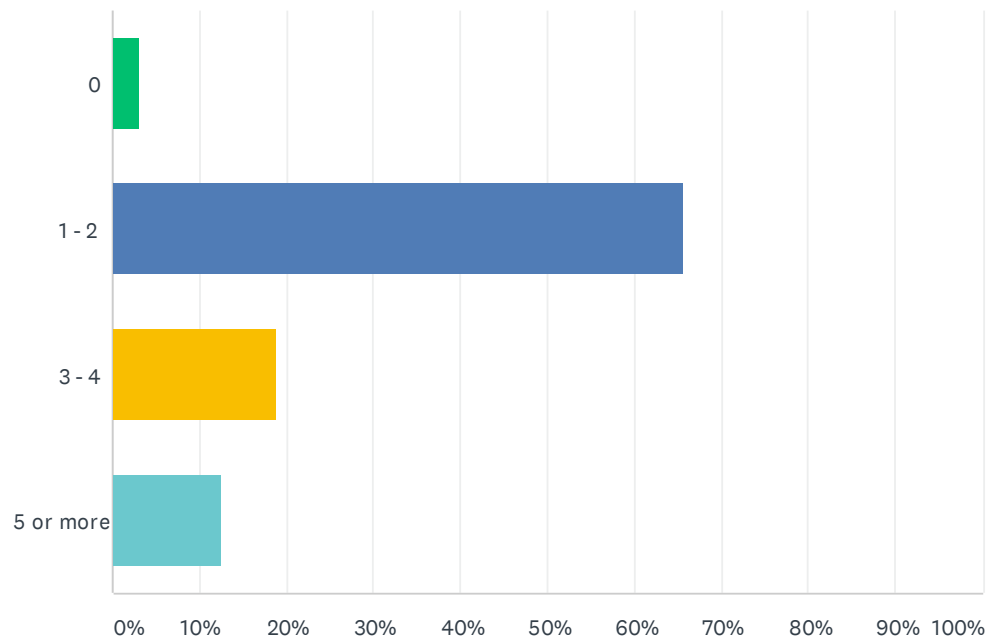

## Q6 How many devices (computers, tablets, etc.) in your home are available or readily accessible for remote learning?

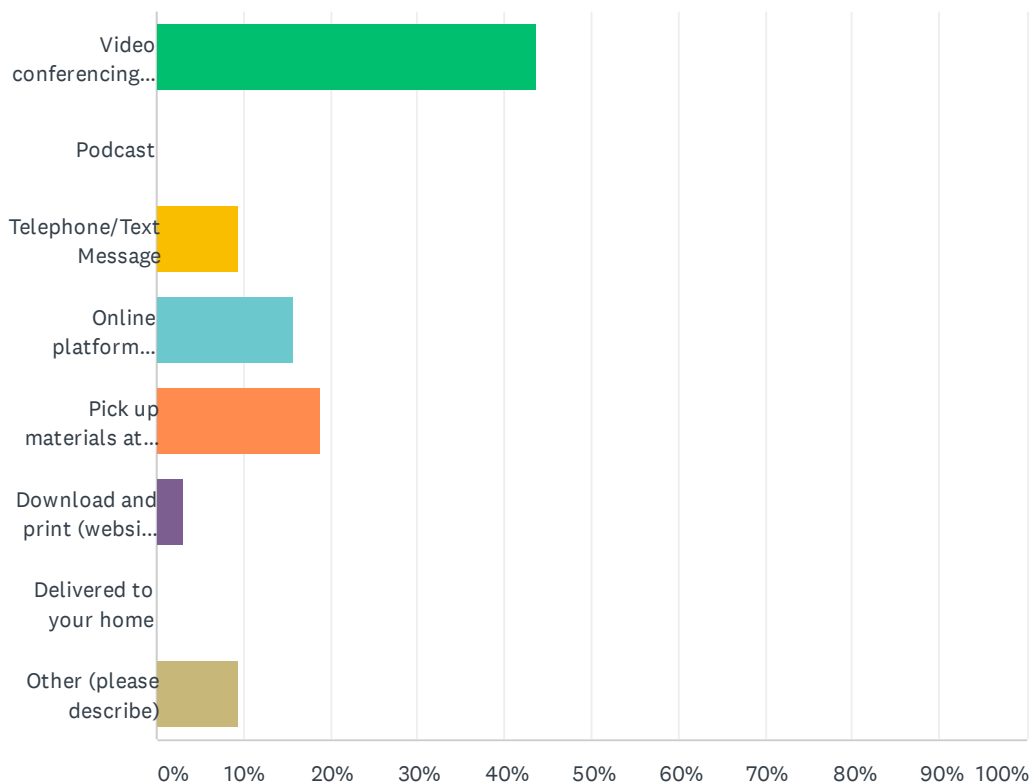

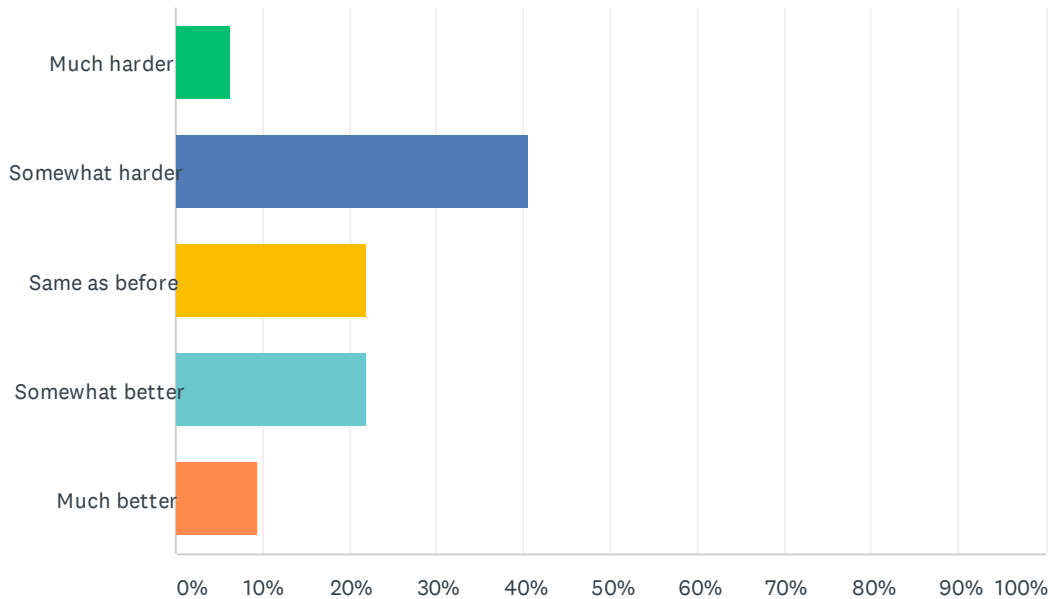
**Q8 How have COVID-19 and the related closures affected your life, family situation and learning experience for your children? (Please describe in the box below)**

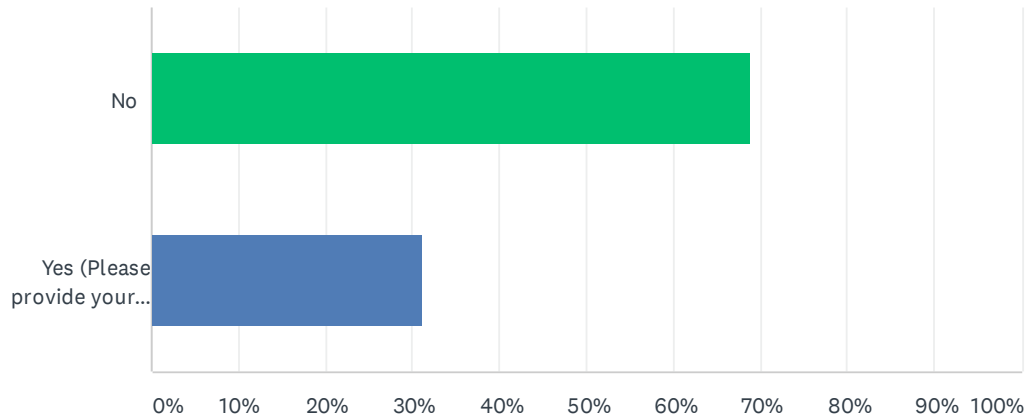

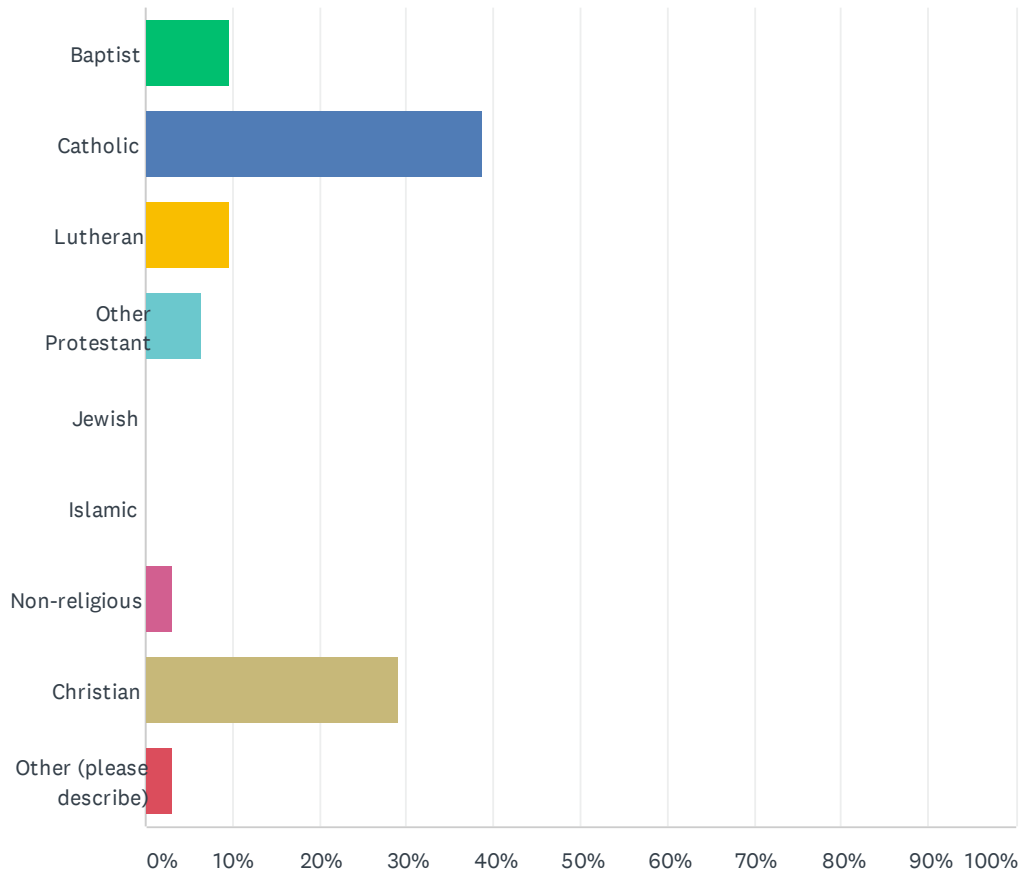

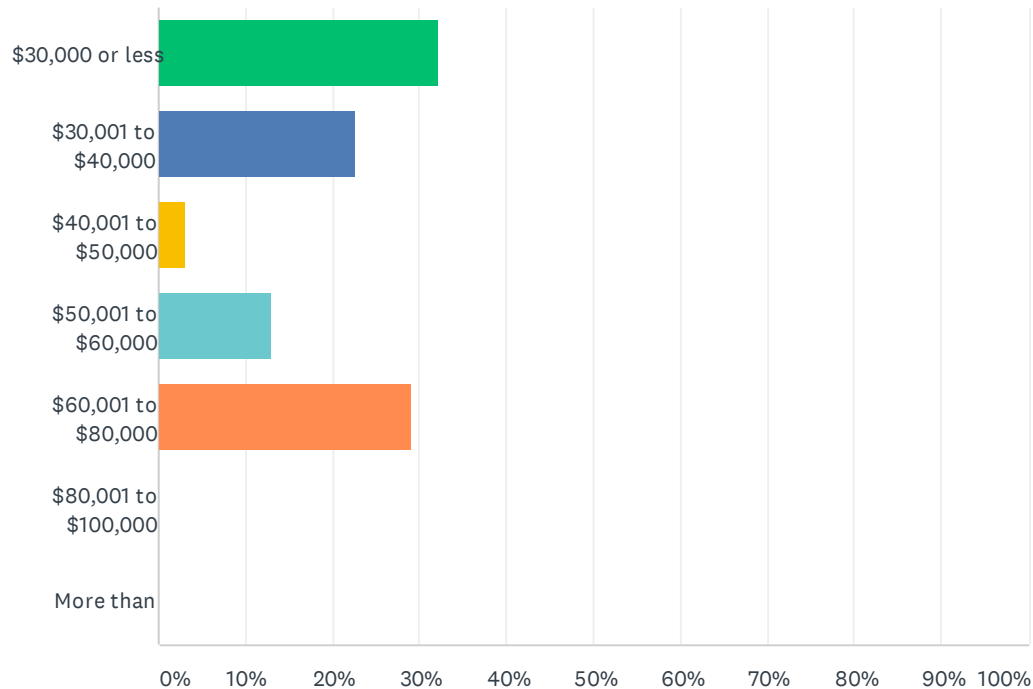

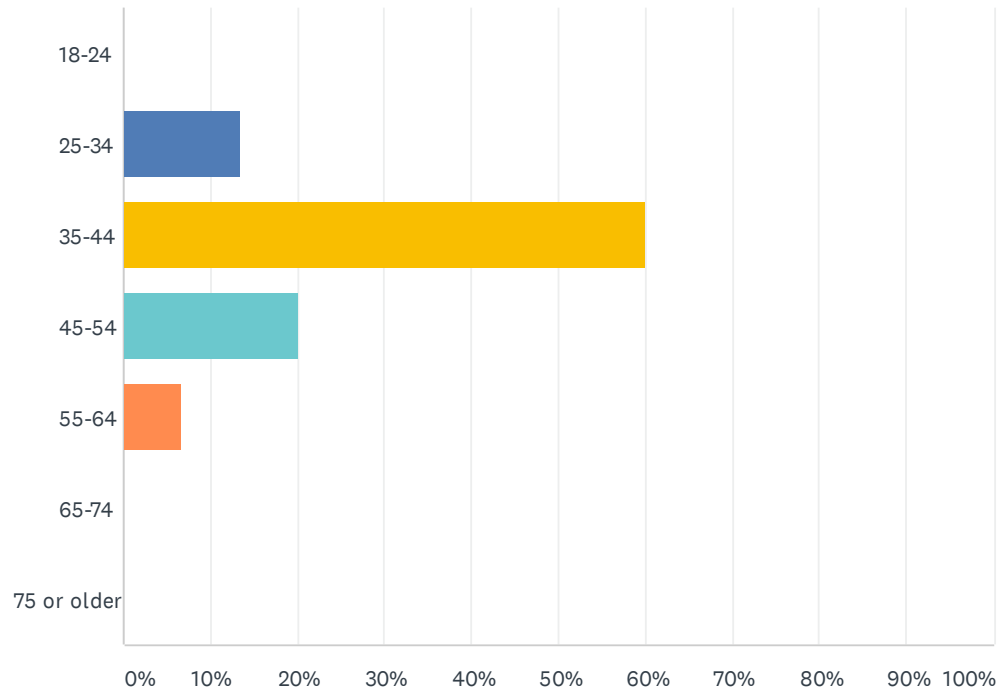

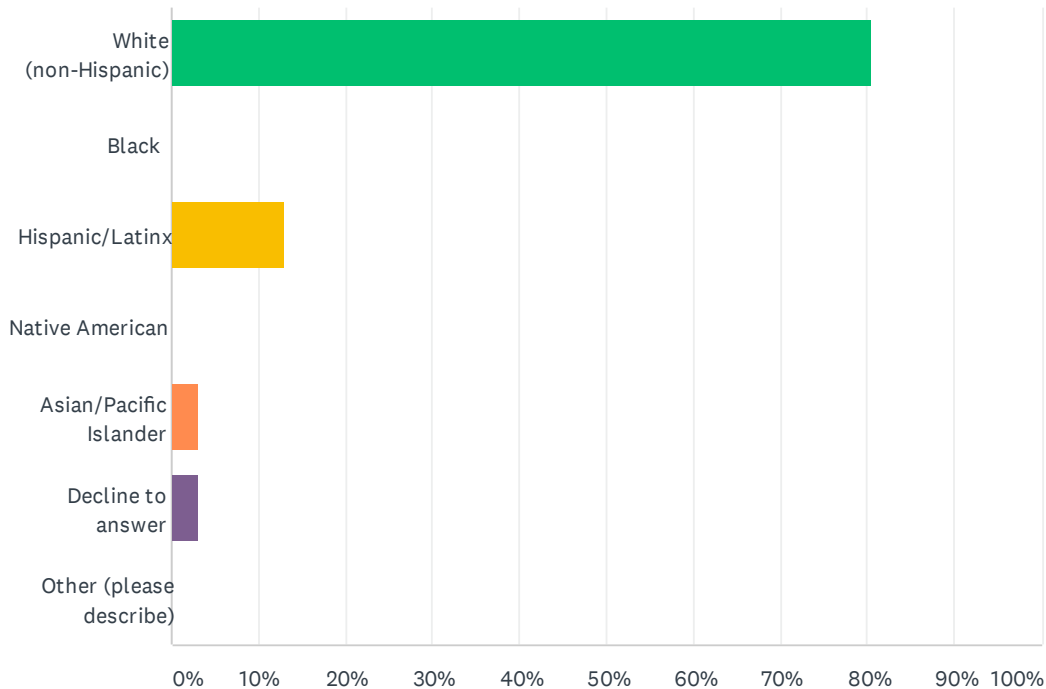

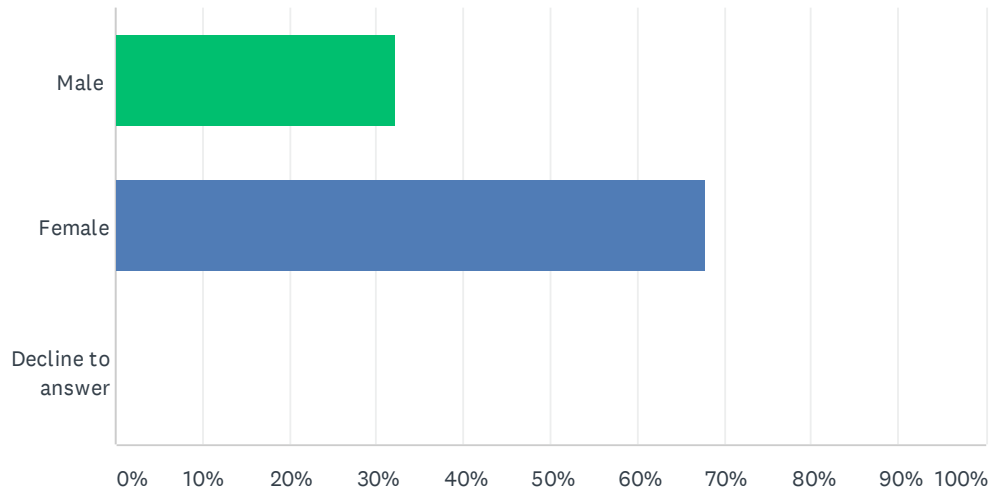
